

1. Introduction

This report presents the findings from our consultation on our proposals for Polling District boundaries and Polling Place locations. The consultation

We have a statutory duty to consult on our review of the parliamentary polling districts and parliamentary polling places within the Newcastle City Council area which, includes the parliamentary constituencies of Newcastle Central, Newcastle East and Newcastle North. The consultation took place between 1 September 2017 and 6 October 2017 (the consultation period).

Our consultation approach

We set up an online consultation using Let's talk Newcastle online: www.letstalknewcastle.co.uk. People registered on the site were sent email invitations to participate in the consultation, targeted by which area they lived in. We also invited various community groups to take part in the consultation, put a video on our social media accounts, and asked NCVS (Newcastle Council for Voluntary Service) to advertise the consultation in their e-bulletin. Finally, we held four drop-in events in the city centre, north, east and west of the city for people to discuss the proposals in person.

Feedback to people who took part

We will publish the final decisions on the polling district boundaries and polling place locations in early 2018. This will include press releases, web information and social media, and an email to people who took part via Let's talk Newcastle online. Information about this will also be available via the Newcastle City Council website in due course. We would like to thank all the individuals and organisations who took the time to give us their views.

2. How many people took part?

We received a total of 107 responses via the Let's talk Newcastle Online consultation. In addition, six people took part at the drop-in events.

Of the people who took part and gave us some information about themselves, just over half gave their gender as male, the largest age group was people aged 65 and over, the most common employment status was "I am retired", and most participants gave their ethnicity as White British.

3. Summary of findings

1. Arthur's Hill

Three people gave us their views on the proposals for the Arthur's Hill ward, with mixed levels of satisfaction and dissatisfaction on the proposals. Two people commented as follows on the proposals for polling district A04: "It would be better to have a Polling Station located near the centre of the polling district [A04] rather than at the periphery" and "The church [Westgate Baptist Church, the proposed location for polling station A04] is fine, but it is a fairly long uphill walk from the bottom of Westgate Road, where I live. It's been there for a while and I worry that it stops people coming. The old location of St. Matthew's at Big Lamp was better: it is at the mid-point of the area, and only half as much uphill for those on the hill."

2. Benwell and Scotswood

Four people commented on the proposals for the Benwell and Scotswood ward, with mixed levels of satisfaction and dissatisfaction on the proposals. They gave these comments: "this is okay" and "This is the polling station [at Denton Burn Methodist Church] which I already use and I have no problem with using it. I have no complaints about the [proposed] boundaries".

3. Blakelaw

We did not receive any feedback on the proposals for Blakelaw ward.

4. Byker

Two people commented on these proposals. One was very satisfied with the proposals. Another felt that they were not fair to people living in the St Peter's Basin area; their comments included: "It is unfair to expect St. Peter's voters to trek up to Byker Old Town to cast their vote. Why not send Byker Old Town down to St. Peter's to cast theirs? This proposal will deter St. Peter's voters from voting."

5. Callerton and Throckley

Two people commented on these proposals. They were mostly neither satisfied nor dissatisfied with the proposals. We received this comment: "E07 may well have no resident electors currently, but will have when you have desecrated the green belt with an unnecessary housing development. E05 / E06, formerly part of Castle Ward, still has a greater affinity with Northumberland than Newcastle. The review should have recognised this and returned them [to Northumberland]."

6. Castle

Three people commented on these proposals. Generally speaking, one was very satisfied, one satisfied, and one neither satisfied nor dissatisfied with the proposals. One commented: "Why split Kingston Park by the Metro line? Would community interests not

be better served by keeping Kingston Park together and losing Dinnington and Hazlerigg to a ward more in line with that area?"

7. Chapel

Three people commented on these proposals. Mostly one was very satisfied, one was satisfied, and the other neither satisfied nor dissatisfied. We received the following comments:

"Many people use the area around Chadca every day, so I see no reason why it would be difficult to get to, other than for those who already struggle to get to places. I can't think of anywhere else in the G01 area that could act as a polling station. You could put a mobile one in Peregrine car park?"

"For existing housing the Chadca Centre is fine, but if you do proceed with building on the farmland opposite Abbey Farm / Abbey Grange, then this will be quite a walk for people living there" and "You could have a mobile station in the Londis car park".

8. Dene and South Gosforth

Nine people commented on these proposals. Their levels of satisfaction varied considerably; some satisfied, some dissatisfied. Comments included:

"Our Polling Station has always been St Nicholas Church Hall on Station Road and should remain so!"

"I doubt only two temporary buildings will be large enough to accommodate a surge of last-minute voters, as the catchment area is much bigger than now."

"The temporary buildings are some distance to walk for residents in South Gosforth. This station can get very busy as it is quite a large polling district which normally has a high turnout. This can lead to people having to queue outside, which is not good if the weather is bad. I would propose extending H02 southwards to incorporate Balmoral, Windsor Sandringham, and Audley, Stoneyhurst Road and Dene View, Crescent, etc. I would then suggest that the polling station for that district should be combined with the proposed station for L04 in the neighbouring Gosforth Ward which is very close to the boundary and would be more convenient for residents in South Gosforth than going to Newlands Road. The station for the smaller H01 area could remain at Newlands Road."

"The Council have allowed this stupid carve-up of Gosforth's wards. The South Gosforth boundary should have been the Ouseburn. How South Gosforth ended up in the Heaton Ward is beyond belief! Poor attention by this inept Council!"

"It seems odd to use a polling station in a different parliamentary constituency."

"We used to use the temporary polling station on Lealholm Road. Reducing the number of polling stations will increase congestion and parking problems around the Haddricks Mill junction."

"Combining H03 with H04 may cause problems with parking, especially given the residents' parking scheme in operation around Trinity Community Centre".

"The new boundary for my street on Gosforth Terrace is stupid, as the Church Hall Station Road is on my doorstep. At our age the long walk to Freeman Road is too far. My wife and I will no longer vote thanks to the 'new' boundary."

9. Denton and Westerhope

We did not receive any comments on these proposals.

10. Elswick

Three people commented on these proposals. They were generally satisfied with them, with one person commenting: "Newcastle Dance Centre is a prominent site which is easy to find."

11. Fawdon and West Gosforth

Three people commented on these proposals. They were generally dissatisfied with them, with comments including:

"There are plenty of other buildings nearby that could be used rather than the portacabin [for K01 on the corner of Fawdon Lane and Felton Avenue] which has no parking and is on a very busy road. The boundaries should include all the nearby streets. Cairns Way is the next road up and is missed out, which is crazy."

"I have no objection to the portacabins that are used as temporary polling stations [for K01] in front of my house, however I strongly object to a new building being erected there. I endure enough noise and litter already."

Other comments on individual polling stations were: "I have voted here [at Fawdon Community Church for K02] and it's fine", "I am not even sure where it [Coxlodge Methodist Church, polling station K03] is".

Comments about the proposals as a whole included the following:

"The group of streets around Regent Road / Hedley Street etc. are rightly part of Gosforth, and look to Gosforth High Street as the community focus. They should therefore be included in the Gosforth ward and not tacked on to Fawdon / Coxlodge."

"Some of the boundaries are crazy. Missing nearby streets out means people have to walk a lot further to vote, which leads them to not bother."

"Please put this part of Gosforth back with the rest of Gosforth where it has traditionally belonged, and to which it has an established affinity."

12. Gosforth

Six people commented on these proposals, with varying levels of satisfaction and dissatisfaction. Comments included:

"The new boundary excluding South Gosforth from Gosforth is a stupid idea!" "This [polling station L01 at Westfield School] is on the main road and near the bus stop, it will be easy to walk to."

"The boundaries are wrong. Gosforth Terrace should not be in the Dene ward!"

"It [polling station L02 at All Saints Church Hall] seems quite near Westfield School and should be nearer the High Street."

"There should be easy access to the polling station [L02 at All Saints Church Hal), although roads around can be busy, parking requirements should be limited due to close proximity for most people. It is a well-known location so should be easy to locate."

"This polling station [L03 at Gosforth Parish Church Hall] is further apart than the others and is not in L03. Why not use the cricket ground?"

"I have been using this polling station [L03 at Gosforth Parish Church Hall] for the last 25 years and have always found it accessible with young children and a disabled daughter."

"It [polling station L04 at Gosforth Parish Church Hall] seems fine." o

“As for L03, it [polling station L04] is also close to the Metro and bus stops, and parking is ample”.

“The South Gosforth carve-up is totally stupid. My street, Gosforth Terrace, should not be in Heaton (Dene Ward).”

13. Heaton

Seven people commented on these proposals, and were mostly satisfied with them. Comments included:

“Although keeping the southern boundary in the middle of Simonside Terrace preserves a current boundary, I think this continuity will be outweighed by the confusion caused to residents on the ‘evens’ side of Simonside Terrace by having a polling station opposite them that is not their own. I suggest that the boundary goes down the back lane between Simonside Terrace and Rothbury Terrace. This will have the added advantage that postcode-based ‘who is my councillor’ online services will work properly (currently, most tell residents on the ‘odds’ side that they are in South Heaton).”

“It [polling station M02 at Ravenswood Primary School] is very convenient for me, I have used it for over 20 years” and “Given the numbers of residents and varying turnout, perhaps it is worth having two polling stations within this polling place [M02]?”

“As for Simonside Terrace / polling district M01, I suggest the boundary should go down the Tosson Terrace / Cartington Terrace back lane. It’s much easier to explain to residents where they should vote if you can just ask them which street they live on (and which side of Chillingham Road), without also having to ask which side of the street. (I had several enquiries on polling day. With high turnover, many residents don’t already know their previous polling station location). See also the rationale I gave for the use of a back lane as the boundary for polling district M01. Also, in recent elections Heaton Community Centre saw queues at 10pm due to high turnout, and this could recur given the removal of a separate polling station for the ‘railway terraces’ (for the current polling district RDE). I agree that it is best to be rid of the temporary building and, given rule changes, it’s always possible to get lots of voters into Heaton Community Centre and shut the doors at 10pm. But it may be worth having two polling stations in here in case of high turnouts, at least for national elections and referendums.”

“All the proposed locations seem quite well positioned and well served by public transport.”

“They all make sense and are on or very close to the No. 1 bus route”.

14. Kenton

Seven people commented on these proposals. They were mostly satisfied, although some were dissatisfied with the proposed polling district boundaries. Comments included:

“We are currently in Kenton Bar ward and wish to remain so.”

“This [polling station N02 at Kenton Park Sports Centre] seems to be a good place” and

“This [polling station N02] seems to be in a logical place”.

“[Polling station N03 at Kenton Customer Service Centre and Library is] a very accessible choice of venue”

“It [polling station N03] should have easy access for people – it has a ramp and wide aisles”.

“This [polling station N04 at the Church of the Ascension Church Hall] is an excellent choice, very accessible.”

“It [polling station N05 at the Younger Scout Centre] is an accessible venue and location.”

15. Kingston Park South and Newbiggin Hall

Six people commented on these proposals, with varying levels of satisfaction. Comments included “It’s my current polling station [O01 at Gala Field Centre] and I think it’s fine” and “The building [polling station O04 at St John the Evangelist Church] is extremely easy to access via any form of transport. The access for disabled people is good, it is on the ground floor with no need for ramps”.

16. Lemington

One person commented on these proposals, and was generally satisfied with them.

17. Manor Park

Four people commented on these proposals, with varying levels of satisfaction. Comments included: “High Heaton Library is an excellent venue. It is central. It has disabled access and a toilet for my disabled husband. It provides chairs for those less able and waiting. If the library is open it is useful to combine a trip there” and “These proposals look satisfactory”.

18. Monument

Three people commented on these proposals with varying levels of satisfaction. Comments included: “You have taken us out of Wingrove ward with a very accessible polling station at Morpeth Street. We are residential flats on Claremont Place, and would rather not be in a ward with the hospital and university. Please could you put us back into Wingrove?” and “The existing polling station at Rossetti Studio is easily accessible and has an access ramp”.

19. North Jesmond

Ten people commented on these proposals. They were mostly satisfied with the proposals, with the exception of the proposal to locate polling station S03 at Holy Trinity Church, where views were mixed and some people were dissatisfied. Five people commented on this latter proposal as follows:

“I think a polling station should be in the ward it represents. This is in South Jesmond ward and so sometimes causes confusion, although it is nearby and convenient for some people.”

“This is eccentrically located at the edge of the area.”

“Holy Trinity is not central to the polling district, which has some quite steep hills and is therefore difficult for some people to access. The church itself is on a slope and the access is not very easy for those with mobility difficulties. The cricket club on Osborne Avenue would be easier for most electors.”

“I am satisfied.”

“Somewhere more central is needed, e.g. the Cricket Club.”

20. Ouseburn

Three people commented on the proposals, with varying levels of satisfaction. Comments included:

“This [the proposed location of polling station T01 at Caring Hands Charity] is fine for able-bodied people, who live very close by, but not for anyone else”.

“I would prefer to use the proposed location for polling station T01, but the proposed location T02 [at St Cuthbert’s Church] is quite far from voters who live towards the west.”

“It [the proposed location for T03 at St Vincent de Paul Society] has limited parking in the area, but it is right outside a bus stop, and has good access for those who can walk to the church.”

21. Parklands

Ten people commented on these proposals, and were mostly satisfied with them. Comments included:

“The Grange First School [for polling station U01] is well-positioned for those voters living close by, but parking is a bit of a problem. It is quite a walk from public transport for the elderly.”

“I use postal voting.”

“I am concerned that some people may not know about the new ward boundaries and where to vote. I don’t think enough information has been put out into the public domain.”

“This polling station [U05 at Gosforth East Middle School] is not that close to public transport. Depending on what time you vote, parking could be a problem” and “This school [Gosforth East Middle School for polling station U05] should not be used as a polling station as it results in the school closing, affecting nearly 400 pupils and their families. Half of these pupils are years 7 and 8, so not primary-school age. There are other schools in this area which are smaller with younger children (and therefore parents who are less likely to be in work.) No school should be used as a polling station but particularly not this one. Why not think differently and have a temporary polling station in the Asda car park?”

“This [Garden Village Hall for polling station U06] is a brilliant place, there is nowhere better.”

“The building [Garden Village Hall] is very easy to access. Everything is at ground floor level, there are no steps and the entrance is only a few yards from the public pavement.”

22. South Jesmond

Seven people commented on these proposals, who were mostly satisfied. Their comments were:

“The location [Jesmond United Reform Church for polling station V01] is good, with parking and easy access.”

“The church [Jesmond United Reform Church for polling station V01] is fine both for its location and accessibility.”

“The church [Jesmond United Reform Church for polling station V01] has been used for a long time, it is as far as I know wheelchair-friendly. I do all my voting by post, not because I am disabled but because it is simpler to vote and post than it is to attend a polling station on a given day.”

“It’s not my polling station [Jesmond United Reform Church for polling station V01], but has it always been the polling station location for that area?”

“I can’t think of another location which has that sense of community which the church hall [Holy Trinity Church Hall for polling station v02] offers”.

“The Reform Church is the best one to use [for polling station V03]”.

23. Walker

We did not receive any comments on these proposals.

24. Walkergate

Four people commented on these proposals and were mostly satisfied with them. We received the following comments:

“Having used this polling station [X01 at Walkerville Community Centre] for a number of years, I am very happy for it to continue to be used in the future. It is a short distance from a lot of houses, so people can walk, but also has enough parking for anyone driving to cast their vote.”

“The football club house [East End Football Club] is fine for polling station X02”.

“The proposed polling station [X04 at 33rd Scout headquarters] does not appear to be central within the area it covers and it may pose problems for those people who find it difficult to get around. I do not know the location so cannot comment on accessibility. My family complete postal votes so will not be directly affected.”

25. West Fenham

Three people commented on these proposals. They were mostly satisfied, except with the proposal to use the City of Newcastle Scout Hut for the polling station for district Y02. We received the following comments:

“The proposed polling place is very inconvenient for residents in the northern half of the proposed polling district, being located on a busy main road with little or no parking. It is beyond what I would regard as reasonable walking distance, especially given that I have to fit in voting at the beginning or end of the working day. I strongly prefer to vote in person, and this would make it extremely difficult for me to do so. The shape and extent of the proposed district seems unhelpful, with the majority of the population towards the north, but the polling place well to the south: it would surely make more sense to divide Y02 and Y03 closer to north-south – say along Lanercost Drive. If the school cannot be used as a polling place (I’m sure it has been in the past, but appreciate the difficulties), perhaps Holy Cross church and / or church hall would be appropriate, being fairly central.”

“As a resident on the border at Cuthbert's Road, it would be easier for me to be in Y03.”

“Can a more central location [for polling station Y02] not be found? I live at the top end of Y02.”

“Adequate parking is vital for whatever polling places are chosen: I can't speak for the other two locations, but I pass the Scout Hut on Silver Lonnen regularly and cannot see how it would be possible for voters to park reliably in the vicinity, especially during morning and evening rush hour. It is surely desirable that polling places should be located as centrally as possible within the districts, for the convenience of all residents, and to make it as easy as possible for people to vote. Neither the boundaries of district Y02 as presently drawn, nor the proposed polling place, are conducive to encouraging turn-out.”

26. Wingrove

Four people commented on these proposals, who were mostly satisfied but with some dissatisfaction about polling district boundaries. We received the following comments:

“St. Robert's Church Hall is a most appropriate venue [for polling station Z01], having good access for all potential users”.

“This [St James and St Basil's Church Hall] is a fine venue [for polling station Z02]”.

“There are residential properties along the edge of Claremont Road which have been taken out of Wingrove ward and separated from the rest of Spital Tongues. If you redraw the boundary and make it go along 'Lover's Lane', that would put us back into a residential ward rather than in with the hospital, university and football ground.”

About the people who took part

Of the people who took part and provided personal information, we can say that;

- Just over half gave their gender as **male**.
- The most common **age group** was people aged 65 and over.
- The most common **employment** status was being retired.
- The most common **ethnic group** was White British

Feedback from drop-in events

We did not received much specific feedback on the proposals at the drop-in events. Most of those who attended used the opportunity to check whether there was any change to their voting arrangements, and discuss other issues relating to life in their neighbourhoods. The attendance was as follows.

Byker Library (east) – three people attended, all found that there was no proposed change to their ward, polling district or polling station.

Gosforth Library (north) – two people attended and checked the details for their own home and their family members' homes and found in both cases that there were no proposed changes to their wards, polling districts or polling places.

Outer West Library (west) – no residents attended.

City Library (city centre) – around seven people visited the stall, where staff identified their individual circumstances and told them where their polling station would be under the proposals. More than half would see no changes. There were no adverse comments about the proposals.



Three people gave us their views on the proposals for the Arthur's Hill ward.


a. A01 Stanton Street Community Lounge

Polling district boundaries




Two people said they were dissatisfied with the proposed A01 polling station at Stanton Street Community Lounge from the point of view of travelling to the building.

One person was satisfied with the proposed polling district boundaries for A01, and another was neither satisfied nor dissatisfied.


Suitability of the building



One person was neither satisfied nor dissatisfied with the proposed location of polling station A01 at Stanton Street Community Lounge from the point of view of the accessibility of the building.


b. A02 Moorside Primary School Library

Location




One person was dissatisfied with the proposed location of the A02 polling station at Moorside Primary School Library from the point of view of travelling to the building.

One person was satisfied with the proposed polling district boundaries for polling district A02.


Suitability of the building



One person was neither satisfied nor dissatisfied with the proposed location of the A02 polling station at Moorside Primary School Library from the point of view of access to the building.



Location





One person was neither satisfied nor dissatisfied with the proposed polling district boundaries for polling district A03, and two people were satisfied.


Suitability of the building



One person was neither satisfied nor dissatisfied with the proposed location of the A03 polling station at Spital Tongues Beacon Community Centre from the point of view of access to the building.


d. A04 Westgate Baptist Church

Location




One person was dissatisfied with the proposed location of the A04 polling station at Westgate Baptist Church from the point of view of travelling to the building.

“It would be better to have a Polling Station located near the centre of the polling district rather than at the periphery.”



Four people commented on these proposals.


a. B01 Broadmead Primary School

Location





One person was satisfied with the proposed polling district boundaries for B01, and three people were neither satisfied nor dissatisfied.


Suitability of the building


b. B02 Denton Burn Methodist Church

Location





Suitability of the building





We received the following two comments: "This is okay" and "This is the polling station I already use and I have no problem with using it, I have no complaints about the [proposed] boundaries".


c. B03 Broadmead Way Evangelical Church

Location





Three people were neither satisfied nor dissatisfied with the proposed polling boundaries of the polling district B03, and one person was very dissatisfied.


Suitability of the building













The chart shows the gender of the 106 people who took part in the online survey and answered this question; just over half were male.




Age
